

Coverage overview (*)

Personal Assistance

- medical expenses abroad: unlimited
- repatriation for illness, accident or death: unlimited coverage
- lengthening or upgrading of a trip for medical reasons
- medical follow-up in Belgium up to 6250€ after an accident abroad
- family assistance if a minor or a person travelling alone is hospitalised
- early return for compelling reasons: hospitalisation or death of a close relative, serious home damage, etc.
- search and rescue costs, including off slope
- sending replacement medications, prostheses, glasses, contact lenses, and luggage
- replacement of lost identity documents
- advance for unforeseen expenses up to 2500€
- reimbursement of the "ski pass", up to 125€

Home Assistance

- assistance in case of home damage
- locksmith charges up to 100€
- information service

Vehicle Assistance

- in Europe, coverage begins 10 km from your home
- vehicles of maximum 10 years old
- caravan or towed-trailer is covered free of charge
- repair and towing
- repatriation of the vehicle, passengers, luggage and pets
- additional nights in a hotel in case of theft or on-site repair up to 65€/night
- sending of spare parts
- continuation of journey or replacement vehicle
- recuperation of the abandoned vehicle
- vehicle surveillance up to 65€
- legal assistance in case of road accidents: lawyer's fees up to 1250€ and an advance for bail up to 12500€

Compensation Trip

- **In case of repatriation**, credit voucher to be used upon your next reservation with the same travel agent

Cancellation

Reimbursement of the cancellation or modification fees in case of:

- illness, accident, death of the insured, a relative to the 2nd degree, professional replacement or travelling companion
- pregnancy, if your trip is planned to take place during the last 3 months of this pregnancy and if you were not already pregnant when the reservation was made
- complications during pregnancy
- death of a related minor up to the 3rd degree
- divorce or factual separation
- home damage
- involuntary dismissal
- resit
- immobilisation of the vehicle following a breakdown in the 5 days preceding the planned trip departure using the vehicle
- inability to receive the obligatory vaccinations
- stolen identity papers or visa, visa denial or entry into the country denied
- appointment to a military or humanitarian mission
- disappearance or kidnapping
- death of the cat, dog or horse
- expulsion from rented accommodation

Basic allocation if the flight to your destination is delayed

Luggage

Compensation in case of:

- theft, damage
- loss or late delivery by public transportation
- intervention for the purchase of essential items: up to 20% of the amount insured

Travel Accident Capital

Compensation after an accident in case of:

- death
- permanent disability

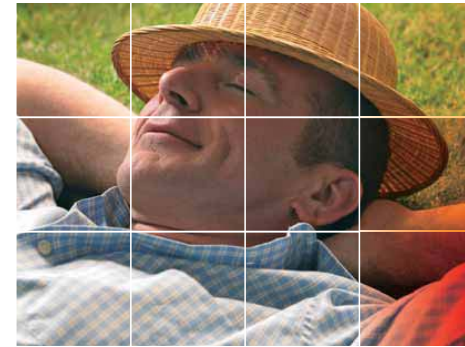

Territoriality: Where does the coverage apply?

Personal assistance

Depending on the contract, territoriality is either Europe and the Mediterranean Basin, or the Whole World.

- **Europe and Mediterranean Basin** : the continent of Europe (except for CIS and Albania), the United Kingdom (Great Britain and Northern Ireland), Ireland, the Mediterranean islands (the Balearic Islands, Corsica, Sardinia, Sicily, Malta, Crete, Cyprus, etc.), the Canary Islands, Madera, Tunisia, Morocco, Asian Turkey, Egypt and Israel
- **The Whole World** : all of the countries in the world

Vehicle assistance

The territoriality of vehicle assistance is Europe.

- **Europe** : the continent of Europe (except for the CIS and Albania) including Belgium starting 10 km from your home, the United Kingdom (Great Britain and Northern Ireland), Ireland and the Mediterranean islands (the Balearic Islands, Corsica, Sardinia, Sicily, Malta, Crete, Cyprus, etc.),

The concept of «Family»

Our family premiums apply to:

- members of a family living under the same roof
- accompanying children who are minors and are not part of the family (max. 2)
- accompanying minors who are the children of a broken marriage and do not live under the same roof
- accompanying grandchildren who do not live under the same roof and who are not accompanied by their parents

Premiums

- Minimum premium: 20 €/policy
- The majority of the premiums cited in this leaflet are valid for trips abroad of maximum 3 months (please consult us for all dispensations)
- Discounts for groups starting from 20 people: please consult us

Subscription

- **When?** Contracts that include cancellation insurance must be taken out during the reservation of the trip.
- **Who may subscribe?** Every person residing in the European Union or Switzerland.
